

## Before you submit your appeal form, we would like to draw your attention to the Local Authority guidance on appealing for places at your preferred school. The guidance is as follows:

- You can only appeal if you have been refused a place at a school you named as a preference on your application.
- If your child has not been offered a place at your preferred school, this is because the school received more applications that there were places available and other children more fully met the admission criteria.

Your son's name will be added to the waiting list for any higher preference schools than the one offered. The waiting list is ranked in line with the school's oversubscription criteria.

You do have a right to appeal for a place for your son. In deciding on whether to lodge an appeal, it is beneficial to consider the following:

- Have you been realistic in the school preferences you put forward for your son?
- Are there exceptional circumstances that would prevent your son from attending the school offered or any of the alternatives available?
- Do you have genuine reasons why your son should not attend a particular school?
- Would your son be at a disadvantage by not attending King's Notion Boys' School?
- Do you have any evidence or documents to demonstrate the points your making?
- Has a mistake been made which has meant that your son wasn't offered a place at a school you applied
  for? If you feel this is the case, you must contact School Admissions and Pupil Placement team at the local
  Authority on 0121 303 1888. This team manages the applications received and offers made for King's
  Noton Boys' School.

Please carefully consider the likelihood of your appeal being successful. Appeals are only generally successful if you or your son have exceptional reasons for needing admission to a particular school.
